## **Modern Slavery and Human Trafficking Statement**

## Financial year ending 31 December 2022

Genesis Investment Management, LLP (referred to as "Genesis", "we" or "our" in this statement) is a limited liability partnership registered in England and Wales under number OC306866 and authorised and regulated by the Financial Conduct Authority. Genesis provides investment management services to an institutional client base from offices in London.

This statement is provided pursuant to section 54 of the UK Modern Slavery Act (2015).

Modern slavery and human trafficking have a devastating effect on countries and communities around the world. At Genesis we recognise the important role that companies have in ensuring they are not knowingly or unwittingly used to facilitate human trafficking or modern slavery in any form. To this end, this statement is supported by a number of policies and procedures to ensure that our business and supply chain remains free of slavery and human trafficking. These include:

- Anti-Bribery and Corruption Policy Genesis has a zero-tolerance approach to bribery and corruption and is committed to acting professionally, fairly and with integrity in all its business dealings and relationships wherever it operates.

  nationality, ethnic or national origin, religion or belief, age, disability, gender reassignment, or
  pregnancy or maternity.
- Procurement Procedure we aim to ensure that all goods and services acquired on behalf of Genesis are acquired in line with procurement best practice.
- Service Provider Oversight Policy which sets out our commitment to good conduct and achieving a good standard of oversight and supervision of service providers.
- Whistleblowing Policy the policy aims to establish processes that provide a confidential and secure way for partners and employees to 'whistle blow' with regard to malpractice in the workplace.

Genesis is committed to ensuring that all employees are treated with dignity and respect and that they benefit from a working environment that respects their fundamental human rights. Our recruitment, interview and onboarding processes are thorough and all new hires are subject to a comprehensive background screening process. Ongoing training is provided to employees and partners on a number of topics including diversity and inclusion, bullying and harassment, and business ethics. Genesis complies will all relevant local laws and regulations.
